FREE SCHOOL MEALS

Dear parent/carer,

All children in Reception, Year 1 and Year 2 are automatically entitled to a Universal Free School Meal. Once children reach Year 3, you will have to pay for their school meals or provide them with a packed lunch.

Some children are eligible for a benefits-related Free School Meal.

What are the benefits of benefits-related Free School Meals?

- Your child will continue to receive free school meals until the end of Year 6.
- School will receive an additional Pupil Premium Grant to support your child's education.
 This funding is extremely important as it allows us to provide the very best possible
 education for each and every child at St Silas CE Primary School. It also helps us to keep
 the cost of things like school trips and school uniforms as low as possible.
- You will receive supermarket vouchers to support you with the cost of meals during the school holidays. Funding has been secured to ensure that families of children who are entitled to benefits-related free school meals will receive a £15 voucher during the summer term and a £75 voucher before the summer holidays.

Am I eligible for benefits-related Free School Meals?

If you or your partner receive any of the qualifying benefits listed below, you can apply for benefits-related Free School Meals.

- Universal Credit your household earned annual income must be less than £7,400 after tax and not including any benefits
- Income Support
